Use: *For hydroponic use:* Fill tank with water. Add BudMajic at a maximum rate of 4ml of 'A' + 4ml of 'B' per litre. Stir thoroughly then check and adjust pH to within the range of 5.0 and a maximum of 6.0. *For soil use or coco fibre:* Ensure soil is well moistened prior to application. Add Add BudMajic to water at a maximum rate of 3.5ml of 'A' + 3.5ml of 'B' per litre then apply directly to root zone.
